Who is inclined to protest when 'Marxist methodology' is presented not with the aid of precise definitions and clear hypotheses but with the aid of a jungle of quotations? I think that the main malfeasance of the current 'Marxist methodology', is that of eclecticism. The methodology of Marx is presented as a collection of trivial and/or obscure ideas but not as a system of statements subordinated to any clear, definite viewpoint presenting a new grasp of the nature of scientific cognition. Search for reconstruction of Marxian methodology as a system of the kind is the main aim of this book.
